The Dundy County Stratton Board of Education met in regular session on February 14, 2011 at the Dundy County Stratton High School. President Metzger called the meeting to order at 6:00 P.M.

President Metzger stated that the board follows the Open Meetings Act Guidelines which are located in the meeting room.
