## BOARD OF EDUCATION DUNDY COUNTY STRATTON PUBLIC SCHOOL BENKELMAN NE 69021

The Dundy County Stratton Board of Education met in regular session on July 08, 2013 at the Dundy County Stratton High School. The following members were present: Mike Blecha, Craig Kerchal, Kent Lorens, Mike Lutz, John Metzger, and Shad Stamm. Also present were Principal Mike Rotherham, Principal Phil Truax, Superintendent Jim Kent, and recording secretary JoAnn Decker. Board members Amy Haines and Sandy Noffsinger were absent. Board member Steve Krug arrived late.

President Stamm called the meeting to order at 6:00 P.M.

President Stamm stated that the board follows the Open Meetings Act Guidelines which are located in the meeting room. The Board of Education may enter closed session during the meeting when it determines that doing so is appropriate and is to protect the public interest and is authorized by the provisions of the Open Meeting Act.

Motion by Lutz seconded by Blecha to verify that notice of the meeting was given by publication in the Benkelman Post, a legal newspaper for Dundy County Stratton Schools, and by written notice to each member of the Board, the designated method of giving notice. There were no public items of discussion.

Superintendent Kent presented the District Technology Report. He discussed the technician's hours, the configuring System Center updates, and the installation of the new laptops and desktop. Principal Rotherham reported on the update of the stove hood for the high school lunch room. Principal Truax reported on the teacher evaluation pilot and Marzano framework implementation plan; back to school student convocation; and assistant coaching assignments. Superintendent Kent reported on Drug Free Workplace Designation Policy 4002; job openings; possibility of using a consent agenda; healthcare reform; upcoming workshops; and the donations of benches.
