BOARD OF EDUCATION DUNDY COUNTY STRATTON PUBLIC SCHOOL BENKELMAN NE 69021

The Dundy County Stratton Board of Education met in regular session on September 9, 2013 at the Dundy County Stratton High School. Principal Mike Rotherham and Principal Phil Truax arrived late.

President Stamm called the meeting to order at 6:03 P.M.

President Stamm stated that the Board follows the Open Meetings Act Guidelines which are located in the meeting room. The Board of Education may enter closed session during the meeting when it determines that doing so is appropriate and is to protect the public interest and is authorized by the provisions of the Open Meeting Act.

Principal Mike Rotherham arrived at 6:18 P.M.

Motion by Metzger seconded by Blecha to approve the administrative and financial reports and payment of bills. Yes: Lorens, Lutz, Metzger, Stamm, Blecha, Haines, and Krug. No: None. Absent: Noffsinger and Kerchal. Motion carried.

Principal Phil Truax arrived at 6:35 P.M.

Superintendent Kent presented the District Technology Report. He discussed the technician's hours; Stratton wireless radio installation; compass learning; Junior High laptop training; Acceptable Use Policies; and replacement of access points. Principal Rotherham reported on enrollment numbers; BWTelcom watermelon feed; head coach supervision meetings; technology assignments; fresh fruit and vegetable program; thanked Randy Raile and BWTelcom for again sponsoring the Kindergarten "milk break" program at Benkelman Elementary; and upcoming events. Principal Truax reported on school pictures; fall sports numbers; teacher in-service; activity shuttle; foreign exchange student; Junior High runners at cross country meets; and new wall pads for high school gym. Motion by Blecha seconded by Kent to adopt a resolution authorizing the issuance by Dundy County School District 0117 (Dundy County Stratton Public Schools) in the State of Nebraska of its limited tax obligation refunding bonds, Series 2013, in the aggregate principal amount of three hundred thousand dollars (\$300,000) for the purposes of refunding certain outstanding bonds of the District; prescribing the form and details of such bonds; imposing a tax to pay the principal of and interest on such bonds; designating the Series 2013 bonds as qualified tax-exempt obligations; adopting certain post-issuance compliance procedures with respect to the bonds; and authorizing certain actions and documents and prescribing other matters relating thereto. The Board discussed the upcoming Education Committee meeting and the Tax Modernization Study Committee meeting. Board member Amy Haines and Superintendent Kent also reported on the Labor Relations Conference.

Motion by Metzger seconded by Blecha to approve the 2013-2014 Tax Request Resolution for Dundy County Stratton Public School. Yes: Stamm, Blecha, Haines, Krug, Lorens, Lutz, and Metzger. No: None. Absent: Noffsinger and Kerchal. Motion carried.

The Board discussed the multipurpose room remodeling project at the high school.

Motion by Metzger seconded by Haines to direct the administration to take any necessary action to adjust timeline for the remodeling of the weight room/wrestling multipurpose room area and to have bids received prior to the October 14, 2013 regular meeting. Motion by Metzger seconded by Lutz to approve the 2013-2014 bus routes as presented and to authorize the administration to make changes as necessitated by changes in ridership and
