The Dundy County Stratton Board of Education met in regular session on June 8, 2015 at the Dundy County Stratton High School. President Stamm called the meeting to order at 6:00 P.M.

President Stamm stated that the board follows the Open Meetings Act Guidelines which are located in the meeting room.
